BURIAL AUTHORITY - TABLE OF FEES

The fees, payments and sums set out below apply where the person to be interred or in respect of whom the right is granted is, or immediately before his death was, an inhabitant or parishioner of the Parish of Westbury on Severn or, in the case of a stillborn child, where the parents (or one of them) are, or at the time of interment were such inhabitants or parishioners. In all other cases the fees, payments and sums will be trebled.

PART 1 - INTERMENTS

The fees indicated for the various heads of items 1, 2 and 3:-

- a) do not include the digging of the grave,
- b) apply provided the interment is made within 15 minutes of the time arranged with the Clerk of the Parish Council. If not so made an additional £4.00 is payable.

- 1 For the interment in a grave in respect of which an exclusive right of burial has **not** been granted:-
 - i) of the body of a stillborn child, or a child whose age at the time of death did not exceed one month **No Charge**
 - ii) of the body of a child whose age at the time of death did not exceed twelve years **£42.00**
 - iii) of the body of a person whose age at the time of death exceeded twelve years **£84.00**
 - iv) of cremated remains **£41.00**
- 2 For any interment in a grave in respect of which an exclusive right of burial has been granted:-

first interment	£49.00
any interment after the first	£34.00
- 3 For the interment of cremated remains in a grave in respect of which an exclusive right of burial has been granted **£41.00**

PART 2 - EXCLUSIVE RIGHTS OF BURIAL IN EARTHEN GRAVES

- 1 For the exclusive right of burial in an earthen grave nine feet by four feet **£105.00**
- 2 For the exclusive right of burial of cremated remains in an earthen grave two feet by one foot **£41.00**

The fees indicated for the various heads of Part 2 include the Deed of Grant and all the expenses thereof.

PART 3 - MONUMENTS AND MONUMENTAL INSCRIPTIONS

| 1 | For the right to erect or place on a grave or vault in respect of which the exclusive right of burial has been granted:- | |
| | i) a headstone not exceeding 2 ft 10ins in overall height which must be fixed on a pre-cast base (either 3' x 1'6" or 3' x 1'4"). No kerbs, cover slabs, ledgers, chippings, vases to be allowed. | £53.00 |
| | ii) any other monument, not exceeding one foot in height and occupying a space not exceeding one foot six inches by one foot six inches | £37.00 |
| | iii) Tablet of stone in Garden of Remembrance not exceeding 15" x 9". | £37.00 |

The fees indicated for the various heads of this Part include the first inscription. For each inscription after the first a fee of **£20.00** is payable. The fee for a second plaque on a tablet in the Garden of Remembrance shall be the same as for a second inscription. Further plaques on the wall will not be permitted.

Planting of shrubs or rosebushes on graves is prohibited. The Burial Authority reserves the right to level untended graves after a period of twelve months.
